2. Minutes of Previous Meeting

3. Action List

4. Treasurer's Report

The Committee reviewed the Finance Report circulated by Alex. The Committee noted the content of the report and the following items were discussed:

- Current Liabilities –adjustment has been made to ensure that this is a required as the amount should be captured under Retained Earnings.
- Junior Dirt Skills payments have been made to Coaches. Thanks to Jo Dettloff who has donated her coaching fees back to the club.
- Paula to be provided access to Xero in order to issue invoices.
- Discussion regarding agreement protocols prior to withdrawals being made from the club account, and eliminating cash handling at events. Stacey to draft a Financial Management Policy covering processes for cash handling and reimbursements for discussion. Alex to pursue options for electronic payments at events.

5. 2019 Cycling Australia Membership Fees

Paula referred to email from Cycling Australia regarding 2019 membership fees. The Committee approved the fee structure proposed, but also agreed to remove the club fee for non-riding members. Club fee structure is as follows:

Race Licences

- Elite / Masters U65 \$25 club fee as recommended by CA
- Para / Masters 65+ \$12.50 club fee as recommended by CA
- J19 and below no club fee \$12.50 recommended by CA

Ride Licences

- Adult 19 and above \$11 club fee as recommended by CA
- J13 J19 no club fee \$11 recommended by CA
- U12 no club fee \$5 recommended by CA (still the same as a Dirt Master Licence from MTBA)

Non Ride Licences

- \$0 club fee - \$7 recommended by CA

6. Acquittal of ORS Grant

Office of Recreation and Sport Grant received for \$5,000 has been fully expended with funds used for Junior Dirt Skills coaching payments, Uniforms (Pirate Life kit) and Equipment (new Laptop).

Action: Paula to email Alex acquittal form for signature for submission.

7. Governance Documents

Feedback has been received on policies and Role statements previously circulated. Stacey expressed preference for timeframes to be placed on some of the core functions of officers (e.g. Minutes to be sent out within X days of meeting, Financial Reports to be provided X days prior to meeting).

Action: Stacey to provide updates to documents prior to next meeting for consideration.

8. MTB Level 1 Coaching

MTBA has called for interest for Level 1 Coaching course to be held in Adelaide. EOI to be issued to determine level of interest for club coaches to undertake the course. Based on interest, the club may assist with associated costs with an agreement to be made for providing coaching services to the club.

Discussion around coaches being used for Junior Dirt Skills - Paula to follow up with those coaches to ensure that they are appropriately accredited.

9. Any Other Business

9.1 Website Update - Pete provided an update on the website refresh. Paula has been provided access and can now update content. Minor glitches are being worked through.

It was suggested that our membership base be used to engage bloggers / content writers to provide active updates to the site.
