#### 4. New Committee

## 5. Club Affiliation / Transition to AusCycling

Paula confirmed with MTBA that club affiliation paid will be apportioned across AusCycling Affiliation on a dollar per dollar basis Affiliation with MTBA due end of October should be paid. Onboarding email has been completed.

## 6. Para Representation

Mark commented that as a club, we have a focus on para cyclists, but there is limited / no representation or input into Club activities. To that end, he proposed that the Committee invite Loz Shaw to become involved, provide input and ensure that what we offer is in line with para cycling requirements.

Stacey recommended that we also consider a review of our website for DDA compliance, and lever off involvement she has with advisory groups she is involved with.

## 7. Strategic Plan Actions

Update to action plan pending. Paula to follow up with Gemma to circulate to the Committee.

#### 8. New Club Kit

Options for a new club kit were discussed. Committee asked for further refinement on 2 x proposals from Seight and 2 x proposals from Madeleine Steele to be considered.

Design to incorporate updated / modernised font plus sponsor representation on the front. White back and shoulders preferred for visibility on the road.

Paula recommended a mountain biking top also be made available – particularly for juniors doing Dirt Skills who may not want a traditional cycling jersey.

Active Kids Grant has been lodged with the Australian Sports Foundation for \$8,000 which should cover costs of new jerseys for juniors when they are available.

#### 9. Any Other Business

Sponsored Teams – Committee briefly discussed barriers to riders becoming members of PACC teams for Super Series, and joining sponsored teams instead. To be discussed at a future meeting.
